OPENING MEETING:

The Reorganization/Regular Meeting of the Environmental Commission of the Borough of Roosevelt was held on Wednesday, January 16, 2019 at 7:02 P.M at the Borough Hall. The Roll was called by Michael Ticktin, who was re-appointed Chairperson by Mayor Peggy Malkin at the recent January 2, 2019 Reorganization Meeting of the Borough Council. His Three-year term is 1/1/2017 - 12/31/2019.

APPROVAL OF AGENDA:

Chair Ticktin asked for motion and second to approve this evening's Agenda. Motion was made by Mr. Nick Murray, seconded by Ms. Mary Tulloss, and unanimously approved.

APPROVAL OF MINUTES:

Motion was made by Mary Tulloss and second by Mr. Nick Murray to approve the minutes of the Regular Meeting held on December 19, 2018 with the following corrections: On page 37 under Approval of the Agenda, line 1, correct "NickMurray" to read "Nick Murray". On page 38 under Forest Management, line 2, change "Brandy" to read "Brandee" and also on page 38, line 3, under Stream Monitoring, line 2, change "vertebrae" to read "invertebrates". Also take out "She has purchased some" and replace with "She has asked members of the Environmental Commission to save bags like them." Also add "Mary Macher has offered to donate some Red Bud Trees and is willing to help us." On page 39, line 3, change "Cyprus" to read "bald cypress" and the last line change "hard wood" to one word, "hardwood".

REPORT OF COUNCIL LIAISON: Mr. Cody Parker was absent.

REPORTS OF COMMITTEES:

Administative - No Report

Forest Management - Mr. Nick Murray reported that we are near the deadline Feb 15, this year, to submit our paperwork, Annual Accomplishmenat Report for CFMP. It will need the Mayor's signature. He is checking how much we spent and will have this paperwork summary before next week and send copies to our members for review before submitting it. Report will include invasive species removal, replanting native species, maintaining the deer enclosure on the Trail, classes attended. Motion was made for a Resolution authorizing Mr. Murray to proceed with this paperwork by Ms. Felong and second by Ms. Monteleone, passed unanimously. Mr. Murray mentioned that members keep in mind that we need classes taken in the future. Ms. Felong reported that she took a Hazardous Tree Identification class November 30th and learned how to rate problemed trees, checking the root, trunk and crown. A single "major" defect can warrant removal and a problem at the crown indicates a problem at the roots. It is good to check our local trees and head off problems. Chair Ticktin asked what we can do to help or recommend to the Borough and Ms. Felong mentioned a problemed tree which fell near their house. The Borough has been taking care of trees that fall even on private property, which is very unusual for towns to do. Damage is covered by Home Owner's Insurance. It would be good to notify people of problemed trees, if possible. Mr. Steve Taylor mentioned that his daughter's town has tagged all the trees. Several members mentioned tree experiences they have had or know about. It was suggested that we apply for a grant to help work with local trees.

<u>Invasive Plant Species</u> - Mr. Steve Taylor reported that they have a number of activities for 2019. They will continue to plant and label plants on Spruce Lane and ask that the Borough help mow further back to help with the poison ivy. Expanding west could be a project in 2019. There are some Autumn Olives in several sections and other piles to remove behind 15 Lake Drive. There is stuff that we took off the Trail that still has to be removed. Mr. Taylor mentioned that approval would have to come from the Counsel for locals to help, with residents' paperwork to assume responsibility if anyone gets hurt. We approach Spring pickup, lots of burning bushes and periwinkle, also two cherry trees failing. Mr. Taylor suggests that we put our information on the Borough website to let residents know what we are trying Chair Ticktin agreed that we should get people interested in helping, then we to accomplish. should take this before the Borough Council. There should be paperwork that residents will not sue the town, that they will assume responsibility for their own actions. Mr. Taylor added that we will have milkweed plants for the 4th of July; we need a bush pick-up (burning bush Mr. Taylor asked if we should expand the Spruce Lane area and and periwinkle, etc.). whether to get a group working behind 15 Lake Drive, and how we should enable residents to get rid of invasive species. We need to firm up some projects and work with the Council. Mr. Nick Murray will be distributing a 2018 DO NOT PLANT LIST that he recently received to residents.

<u>Stream Monitoring</u> - Ms. Mary Tulloss has been checking some other areas to get ideas for working with our problems.

OLD BUSINESS:

Status of Butterfly Garden - Chairperson Ticktin reported that there has been a lot of activity at the front of the Borough Hall. They did not pave over it, but have put stones over the area. They have left three trees there so something could be planted there. We will have to ask at the Council Meeting what the plans are. He is thinking that the alternative space we can ask for is the space behind the Borough Hall next to the other building. In the meantime Steve Taylor says that some species of milkweed can thrive in the wet soil there. It would be nice for educational purposes to have it more prominent. Ms. Mary Tulloss mentioned that it was nicer for the residents to see the milkweed, if it were on the front of the building. Chair Ticktin suggested that she come to the next Council Meeting, express her thoughts and see what their response is. Ms. Tulloss could put it on record that the Environmental Commission apologizes, is sorry about the removal of the Butterfly Garden because it was a demonstration for the Borough residents to see what this garden was like. Let the Council members see there are positive alternatives.

<u>Sustainable Jersey</u> - Chair Ticktin said we need to work on a list of what we can tackle this year. Mr. Nick Murray reminded us that we are working for points. Mr. Ashburner commented on placing articles/advertisements in our <u>Bulletin</u>; points could be made. Mr. Murray said we could work on a list as a group. Also there are some limits; some are priority and some mandatory, which he will check. Ms. Heidi Monteleone is also interested in our working as a group. Mr. Ashburner said that a Tree Inventory and Planting is worth 20 points. Ms. Mary Tulloss asked if Stream Restoration could be an area to work on? Mr. Nick Murray said that Tree Inventory money is sizeable; he will check their *website* for possibilities for the next meeting.
