**Finance:** C/Hamilton explained that the purchase of a functioning snow blower for the Public Works Department would be cost effective and would save on labor costs associated with snow removal. The estimated cost of the snow blower is \$1,200 and C/Hamilton recommended making the purchase

prior to yearend. The consensus of the Council is to purchase the snow blower. C/Trammell suggested purchasing an updated recording system and estimated the cost at approximately \$2,000.

**Utilities:** C/Trammell explained that the filters at the water plant have been flushed and the iron sludge has been removed from both tanks; the tanks were pressure washed and the hydrants have been flushed. This hasn't been done in six years and the recommendation is that this be done every one to two years. This should be included in the budget for regular maintenance of the water plant.
